Motorized Golf Cart / Utility Task Vehicle Requirements / Restrictions

1. Read Article VI and Article VIII of Chapter 40 of the Code of Ordinances of the City of Earlville pertaining to Vehicle Licensing and Motorized Golf Carts and Utility Task Vehicles
2. Headlights and taillights shall be on at all times
3. Operators must be at least 18 years old and have a valid Illinois driver's license
4. Operators and passengers, on a city street, shall obey all ordinances of the City of Earlville and the provisions of the Illinois Vehicle Code as amended from time to time
5. Motorized golf cart or utility task vehicle must have a license from the City of Earlville located on the lower left of the windshield at all times
6. Required Equipment:
 - a. Brakes.
 - b. Steering apparatus.
 - c. Tires.
 - d. A rearview mirror.
 - e. A red reflectorized warning device on the front and rear.
 - f. A slow-moving emblem, as required by 625 Illinois Compiled Statutes 5/12-709, attached to the rear.
 - g. A headlight that emits white light visible from at least five hundred feet (500') to the front.
 - h. A taillight that emits red light visible from at least one hundred feet (100') from the rear.
 - i. Brake lights on the rear.
 - j. Turn signals on the front and rear.
 - k. Seatbelts.
 - l. Windshield
 - m. Safety flag attached to a pole on the rear no shorter than 48 inches high
7. Restrictions:
 - a. No person shall operate a motorized golf cart or utility task vehicle on a City street in excess of thirty (30) miles per hour.
 - b. Motorized golf carts and utility task vehicles may not be operated on sidewalks or other public property not accessible to, or authorized to vehicular traffic.
 - c. Motorized golf carts and utility task vehicles may NOT be operated on Union Street (Old Route 34) EXCEPT between Loraine Street and Grove Street.
 - d. It shall be unlawful to operate a motorized golf cart and/or utility task vehicle on Illinois Route 34, other than to cross while traveling within the City limits.
 - e. Motorized golf carts and utility task vehicles may NOT be operated in inclement weather nor when visibility is impaired by weather, smoke, fog, or other conditions, or at any time when there is insufficient light to clearly see persons and vehicles on the roadway at a distance of 500 feet.
 - f. This ordinance in no way authorizes the use of go-carts, ATVs (commonly known as 4 wheelers), or dirt bikes on city streets.

You will be held strictly responsible for knowing all laws and restrictions associated with the operation of motorized golf carts and/or utility task vehicles within the City of Earlville.

UNCONDITIONAL AND FULL GENERAL RELEASE OF LIABILITY, WAIVER DISCHARGE AND COVENANT NOT TO SUE

This is a legally-binding UNCONDITIONAL AND FULL GENERAL RELEASE OF LIABILITY, WAIVER DISCHARGE AND COVENANT NOT TO SUE made by me _____, (hereinafter referred to as "Operator") to City of Earlville and its Council (hereinafter referred to as the "City").

I FULLY RECOGNIZE THAT THERE ARE DANGERS AND RISKS WHICH I MAY BE EXPOSED TO BY OPERATING MOTORIZED GOLF CARTS AND UTILITY TASK VEHICLES ON CITY STREETS. THE FOLLOWING ARE A DESCRIPTION AND/OR EXAMPLES OF SIGNIFICANT DANGERS AND RISKS ASSOCIATED WITH THIS ACTIVITY, INJURY TO MYSELF OR OTHERS. IN NO EVENT SHALL THE CITY BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER ARISING IN TORT, CONTRACT OR ANY OTHER LEGAL THEORY, IN CONNECTION WITH OR ARISING OUT OF OPERATOR'S USE OF A MOTORIZED GOLF CART OR UTILITY TASK VEHICLE ON CITY STREETS.

THE OPERATOR, AS OF THE DATE BELOW, SHALL HEREINAFTER SAVE, HOLD HARMLESS AND INDEMNIFY THE CITY AGAINST ANY AND ALL LIABILITY, CLAIMS, CAUSES OF ACTION, AND COSTS OF WHATSOEVER KIND AND NATURE INCLUDING WITHOUT BEING LIMITED TO: INJURY, DAMAGE, LOSS INCLUDING DEATH, RESULTING FROM ARISING OUT OF OR OCCURRING IN CONNECTION WITH THE USE OF A MOTORIZED GOLF CART OR UTILITY TASK VEHICLE ON CITY STREETS.

I understand that the City has an ordinance governing the use of motorized golf carts and utility task vehicles on City streets and hereby agree to conform with all requirements of the City ordinance at all times. I have had the opportunity to read said ordinance and my signature below acknowledges that I will comply with this ordinance and all of the applicable traffic laws of the State of Illinois at all times when operating a motorized golf cart or utility task vehicle on City streets.

I, THEREFORE, AGREE TO ASSUME AND TAKE ON MYSELF ALL OF THE RISKS AND RESPONSIBILITIES IN ANY WAY ASSOCIATED WITH THIS ACTIVITY IN CONSIDERATION OF AND RETURN FOR THE OPPORTUNITY TO OPERATE A MOTORIZED GOLF CART OR UTILITY TASK VEHICLE ON CITY STREETS. I RELEASE THE COUNCIL (AND EMPLOYEES AND AGENTS) FROM ANY AND ALL LIABILITY. CLAIMS AND ACTIONS THAT MAY ARISE FROM INJURY OR HARM TO ME OR OTHERS, INCLUDING DEATH OR FROM DAMAGE TO MY PROPERTY OR PROPERTY OF ANY OTHER IN CONNECTION WITH THIS ACTIVITY. I UNDERSTAND THAT THIS RELEASE COVERS LIABILITY, CLAIMS AND ACTIONS CAUSED ENTIRELY OR IN PART OF ANY ACTS OR FAILURES TO ACT ON MY PART INCLUDING BUT NOT LIMITED TO NEGLIGENCE, MISTAKE, OR FAILURE TO ENFORCE, SUPERVISE OR MAINTAIN.

I assure the City that there are no health-related reasons or problems which preclude or restrict my participation in this activity. I further assure the City that I have adequate health and liability insurance necessary to provide for and pay any medical costs or property damage that may directly or indirectly result from my participation in this activity, and I will indemnify and hold the City harmless of any such medical costs or property damage.

I understand that this Release means I am giving up among other things, rights to sue the City, its Council, employees, and/or agents for injuries (including death), damages, or losses I may incur or cause. I also understand that this Release binds my heirs, executors, administrators and assigns, as well as myself.

I HAVE READ THIS ENTIRE RELEASE, I FULLY UNDERSTAND IT, AND I AGREE TO BE LEGALLY BOUND BY IT.
