**Vehicle Licensing Fee Schedule**

Cars, Trucks (under 16,000 lbs.) & motorhomes	\$20.00	Annual, renewal in October
Trucks (over 16,000 lbs.) & semi tractors	\$40.00	Annual, renewal in October
Senior Citizens for cars, trucks & motorhomes	\$10.00	Annual, renewal in October
Golf Carts or Utility Task Vehicles	\$20.00	Annual, renewal in October
Business/Vehicle Dealers	\$20.00 per vehicle but no more than \$120.00	Annual, renewal in October
Replacement Sticker	\$ 5.00	

**Fees imposed; payment thru October 31<sup>st</sup>**

- 1) The annual fee to be paid for vehicle licenses shall be as provided on the city fee schedule.
- 2) Business or vehicle dealers that have their principal business location within the city shall be required to pay \$20.00 per plate but no more than \$120.00, regardless of the number of vehicles owned or operated. This does not include a business/dealer vehicle that is also used for personal use. Business/vehicle dealers with more than six vehicles requiring stickers will have a certification of registration posted at their main office in lieu of actual stickers applied to vehicles.
- 3) Senior Citizens - Upon proof that the owner/owners of the vehicle is/are age 65 years or older, the fee for licensing a car, truck or motorhome shall be one-half the fee listed in the city fee schedule.

**Payment after October 31<sup>st</sup>**

- 1) If the fee is not paid by October 31<sup>st</sup> of each year, the late charge for the vehicle license will be double the original fee.
- 2) If the fee is not paid by November 30<sup>th</sup>, the person will be subject to penalties for violation of this chapter as well as the late charge for the vehicle license
